- 01.02.15 **Minutes of the last meeting** held on 19 January 2015 were read and it was resolved to accept these as a true record of the meeting and they were signed by the Chair.
- 02.02.15 **Public Participation:** Cllr Kerford Byrnes said the results of the Local Plan were due in mid-March and they were expected to be close to the proposals put forward by Cherwell. Some Council Tax relief had been wrongly allocated and was being adjusted.

- 05.02.15 Grievance Procedure Councillors from another parish would be needed if grievance procedures were ever to be instituted. Mr Coley would arrange to swap Councillors with another parish for this purpose. ACTION: JC
- 06.02.15 Highways/Footpaths The potholes in the road outside the White Lion caused a 90 year old to trip and fall. This accident proves the pothole is a health and safety issue which needs to be stressed with Highways. ACTION:

The annual litter pick will be on 12 April at 10.00am starting at the telephone exchange and at the stone bus shelter. Equipment to be requested from CDC and delivered to Mr Preston.

ACTION: CLERK

The Dales asked for PC approval for bollards to protect the centre portion of the retaining wall at Cedar Court. They will be told approval from Highways is needed for additional bollards.

ACTION: CLERK

Transport Plan4 has nothing specific for this village as it has no details of 'mitigating policy' following the development of Upper Heyford.

Damage is being done to the verges in Fir Lane because some lorries and busses cannot otherwise avoid parked cars. The school will be asked to help prevent this parking.

ACTION: CLERK

The Dr Radcliffe Trust will be asked to cut back the hedge along Robinsons Close. The brambles between Middle Aston and Coneygar Fields could be cut at the same time. **ACTION: CLERK** The road surface at the bottom of Paines Hill is deteriorating again and Highways need to be informed. **ACTION CLERK**

Speeding was to be approached in two ways. Cllr Fatemian needs to be reminded about getting wires to check speeds and a Speed Aware Campaign needs to be started.

RP and ML to talk to Mr Mclusky about the access by The Old Forge where the grass seed is not holding the verge together. ACTION: RP & ML

- 07.02.15 **Risk Assessment:** The risk assessment was approved and adopted. It was agreed an inventory and guidelines on what counts as 'property' was needed. JC would check the papers he inherited from Mrs Mason. **ACTION: JC**
- 08.02.15 **Website:** The minutes of the website meeting were received.
- 09.02.15 **Neighbourhood Watch**: Mr Needle has resigned as the village NAG representative and the organiser of Neighbourhood Watch. It was agreed that the village did not need a NAG representative as it had good relations with the police anyway. However a new organiser for Neighbourhood Watch was required and ML would draft something for SAL. **ACTION: ML**
- 10.02.15 **Meetings:** Thames Water will need to close some roads , but this is unlikely to happen till next year.
- 11.02.15 Play Area/Teenage Facilities: No problems reported

- 12.02.15 Village Hall: The re-roofing of the committee room has been commissioned from Abbot roofing for £2,952.
- 13.02.15Toilet/Cleaner: The vandalism to the cistern was noted and it was agreed the toilet should be
shut at 5.00pm till the clocks change.ACTION: CLERKTo prevent the lid of the cistern being removed BM-H said her husband would screw in a block
above it which could be removed for maintenance as needed. RP would report the incident to

the police. ACTION: BM-H &RP Allotments: The report by Nicholsons on the tree next to the collapsed wall of the allotments concluded that 'It is my opinion that the damage has been caused by the tree.' It was agreed

It was agreed the PC would pay for the tree to be removed and the stump poisoned rather than ground out as it was feared this might bring down more of the wall. Estimates for the work should be sought from Nicholsons, John Whitworth and Kevin Preston. (RP declared an interest as Kevin is his son). CDC will be notified about the removal of the tree. JC would tell Mr Billings about the tree's removal. It is not known who is responsible for the wall except that it is not the PC as it was not specified in the lease when other walls were identified. **ACTION: CLERK & JC** RM said she would check on what was growing on the allotments by the back of Wincote. She explained she did have to get planning approval for a proposed 5mx5m shed. **ACTION: RM**
- 15.02.15Correspondence: The PC was invited to comment on the appeal against refusal by the NHS for
a pharmacy in Deddington.ACTION: ML
- 16.02.15 Planning: ML would represent the PC at the planning meeting on the proposed development opposite Greenacre. The discussion of the proposals had been put off to enable the planners to make a site visit just before the meeting. ML said he would get 5 minutes to make the PC's case which would be based on 4 breaches of the CDC planning policy. ACTION: ML The PC would not comment further on the Caulcott planning appeal.
