09.17.06 New Councillor

Graham Porcas signed the Declaration of Pecuniary Interests Form as required by CDC and was welcomed as a new councillor.

09.17.07 Co-Option of Councillor

The vacancy created by Richard Preston's resignation requires a councillor to be co-opted and it was decided by the secret vote to invite Charlotte Clarke to join the parish council.

ACTION: CF to write to Charlotte inviting her to accept the post of Councillor.

Two vacancies remain; The one created by Anna Allen's resignation must be filled by co-option. The other is as a result of only one nomination for the two posts available by election. Notices for this vacancy will be issued by CDC on 13th October and if there is no call for an election this vacancy will also be filled by co-option. The council was sorry to learn of Anna's resignation and wished to thank her especially for her work on the playground area and overhanging foliage.

ACTION: SF to write to Anna Allen thanking her for her time on the PC Highways/Footpaths

- The broken slabs on Fenway/Northside have been replaced by OCC.
- Resurfacing of Heyford Road following the 'Duck' campaign has been completed - thanks to HW and ML for their efforts.
- White lining has also been renewed throughout the village.
- Mr. Atkins wished to discuss the trenches created by OCC on Fenway/Water Lane which are deep and when driven over by lorries the vibration is causing damage to his property. OCC have said that the depth is not great enough to warrant repair. Clerk to contact OCC.
- The foliage overhanging Fenway by Westfield Stables has still not been trimmed despite a letter having been written to the owner.

ACTION: SF to write a further letter.

09.17.12 Play Area

- Bark and sand has been delivered and spread by Trevor Stewart and the Zipwire adjusted.
- The Bike Trail continues to be used as a bike trail and a notice has been put up which reads:

This area is an adventure bike track. You use it at your own risk and are strongly advised not to do so when there is nobody around to raise the alarm in case of an accident. The gate must be closed when the track is in use. Bikes must not exit through the gate at speed. Non-bikers should not interfere with the track and should not enter whilst it is in use. Any concerns about the state of the track should be reported to the Clerk to the Parish Council (Tel:.....)

A complaint has been received from one of the group who built the trail that children are playing in the area and destroying the jumps. It was agreed that for the time being it should remain as a Bike Trail and that Bob Bickley be asked to include it in his weekly inspections. To be a Standing Agenda item.

- Bob Bickley's contract requires re-writing as it is too vague, particularly as he is required to prune hedges and does not have the necessary equipment.
- The pagoda is still in need of repair. GP to arrange for repairs to be made

ACTIONS: CF to ask Bob Bickley to regularly inspect the Bike Trail GP to repair pagoda

09.17.13 Noise nuisance

Following a wedding in the village last month, a complaint had been received regarding the noise from the reception continuing into the small hours along with a request that the PC issue guidelines with regard to noisy parties. It was decided that this is not a matter for the PC and that 'one-off' parties should be tolerated.

09.17.14 The Old Quarry

Many residents had been concerned in recent weeks about the activity on land known as The Old Quarry behind the Old Quarry House on Fenway. It appeared that the site was being cleared and there was concern that trees and shrubs were being destroyed and wildlife disturbed. CDC attended and have issued TPOs on trees on the site. The land, amounting to some 17 acres, is designated a Local Green Space in the Neighbourhood Plan and following a letter to the solicitor acting for the late owner of the property a response was received by MCNP asking that the nomination for the land to be designated a Local Green Space be withdrawn.

It was confirmed that John Coley is to remain as a non-councillor representative of the PC on the MCNP Forum, along with Martin and Stuart as councillor reps. The consultation on the draft plan has been extended to 3rd October.

09.17.19 Green Space

A letter had been received from a resident of Lawrence Fields requesting that the field behind Nizewell Head owned by Charles Cotterell-Dormer be nominated as a Local Green Space in the Neighbourhood Plan. Mr Cotterell-Dormer subsequently indicated that he does not wish it to be nominated and as it had not previously been considered by the PC and the nomination withdrawn, the PC will not pursue the nomination.
